

CANDIDATES: Important Things To Remember Regarding Campaign Financial Disclosure¹

1. BE INFORMED

Visit the FPPC website for a wealth of information: www.fppc.ca.gov. Study the FPPC Campaign Disclosure Manual 2 - Information for Local Candidates, Superior Court Judges, Their Controlled Committees, and Primarily Formed Committees for Local Candidates. Review Coronado's Campaign Regulations in Coronado Municipal Code Chapter 1.84 which has additional local campaign restrictions. Local candidates also should ask the City Clerk about any additional local campaign restrictions. *Please be aware Coronado has enacted stricter regulations than the FPPC.*

2. BEFORE RAISING OR SPENDING ANY MONEY

File Form 501 (Candidate Intention). Then open a campaign bank account. Once \$200 is raised or spent, get an identification number by filing Form 410 with the Secretary of State.

3. MARK YOUR CALENDAR

Know the due dates for campaign statements and file on time by referring to the FPPC's website.

4. KEEP GOOD RECORDS

Maintain details on contributions and expenditures of \$5 or more. Refer to recordkeeping guidelines in your campaign disclosure manual.

5. \$100 OR MORE IN CASH?

Never spend \$100 or more in cash. Never accept any cash contributions – Coronado only allows contributions to be made by check. Also make sure to make a photocopy of each check by which a reportable contribution is made.

6. USING PERSONAL FUNDS FOR CAMPAIGN EXPENSES

All personal funds of the candidate must first be deposited in the campaign bank account, except for filing fee/ballot statement fee. Coronado's Filing fee is \$25.00 and the Ballot Statement Deposit is \$600.00.

7. REPORT LATE CONTRIBUTIONS

If \$200 or more is received from one contributor during the last 16 days before the election, disclose receipt within 24 hours, even if the contribution is from your personal funds.

8. ITEMIZE CONTRIBUTORS

For contributions of \$5 or more, including loans and in-kind contributions, you must disclose the contributor's name, (street) address, occupation and (name of) employer, or principal place of business if self-employed.

9. IF AN AGENT OR CAMPAIGN CONSULTANT BUYS GOODS OR SERVICES FOR THE CAMPAIGN

Itemize expenditures of \$5 or more made by the agent or consultant.

10. IDENTIFY CANDIDATE/COMMITTEE ON MAILINGS

Include your name and campaign address in at least 6-point font on the outside of all mass mailings (more than 200 pieces). Your committee's name may be used if it includes your name. If your name is not part of the committee's name, you may use just your name, or both your name and the name of the committee.

11. NO PERSONAL USE OF CAMPAIGN FUNDS

Use campaign funds only for political, legislative, or governmental purposes.

13. IMPORTANT DIFFERENCES BETWEEN FPPC REGULATIONS AND LOCAL CORONADO REGULATIONS TO BE AWARE OF²

Coronado has enacted a local campaign ordinance that provides for stricter campaign requirements than the FPPC in some areas. Some of these differences are highlighted below. Coronado's Campaign Regulations can be found in Coronado Municipal Code Chapter 1.84.

Topic	FPPC	Coronado
California Form 410 – Statement of Organization Recipient Committee	Candidates are required to file once \$2,000 is raised or spent.	Candidates are required to file once \$200 is raised or spent.
Recordkeeping Guidelines	Details on contributions and expenditures of \$25 or more.	Details on contributions and expenditures of \$5 or more.
Cash Contributions	No cash contributions of more than \$100 .	No cash contributions are allowed in Coronado – checks only. A photocopy of each check by which a reportable contribution is made must be retained for one year after the date of the related election.
Reporting Late Contributions	For contributions of \$1,000 or more from one contributor during the last 16 days, must disclose receipt within 24 hours, even if the contribution is from your personal funds.	For contributions of \$200 or more from one contributor during the last 16 days, must disclose receipt within 24 hours, even if the contribution is from your personal funds.
Itemizing Contributors	Must disclose contributor's information for contributions of \$100 or more.	Must disclose contributor's information for contributions of \$5 or more.
Itemize Expenditures by Agent or Consultant	Must itemize for expenditures of \$500 or more.	Must itemize for expenditures of \$5 or more.
Contribution Limits	Contribution limits are dependent upon state office, committee, and the contributor.	No more than \$200 during one calendar year per candidate except for a candidate's contribution of his or her personal funds to his or her own campaign contribution account.
